- 4. St Paul Street Evangelization group is praying a Rosary on September 5th at 12 p.m. in front of the police station for our Police. Please join if you can.
- 5. Saint Andrew's church, only through the church donations, gave \$103,072!!!!! This does not count those that gave directly to us!!!!!!! Our parish is SOOOO generous!!!

 - Cash in the second collection is split with St Andrews Social Concerns.
 - If you want AZ tax credit for your donation your donation must be made directly to SVDP. Give the donation directly to Gini or Blanca. Blanca will provide you with a donation letter for tax purposes.
