Toni seconded the motion. Motion passed. The next time she comes to the store she will be given a letter stating she is not allowed on the property for one year. Ann Lund and Jerry will review the letter prior to it being given to Kathleen. The letter will be signed by Martha. If Kathleen causes a scene Shelly can call the police.
