Heather and Ty Baze with Salvation Army along with Mary Mueller provided a presentation on Salvation Army, their mission and the programs they have for supporting the community of Sierra Vista and the surrounding area. Some of the highlights of the presentation were

- 1. Church Activities:
 - Church services, Bible study, Prison ministry, Men's and Women's ministries and Family Movies.
- 2. Social Services Activities:
 - Daily Community Hot Meals: M-F 11:30 a.m. to 12:30 p.m. These meals are provided and cooked by volunteer groups, churches and Texas Road House. During the lunch timeframe, the meal recipients can also pick up food boxes. The food, for the food boxes, comes from FoodCity and Safeway when they pull items from the store shelves and Olive Garden provides frozen soup. This provides the recipients with food for a dinner or meal over the weekend.
 - Emergency Food Boxes: These are provided M-F 9:00 a.m. to 1:00 p.m.
 - Commodities: Sierra Vista, 1st and 2nd Tuesday of each month. Hereford 1st Tuesday 8:00 to 9:30 a.m. and HuachucaCity 3rd Friday 8:00 a.m. to 9:30 a.m.
 - Rent and Utility assistance. At this time they are out of funds for rent but are applying for grants.

UNFINISHED BUSINESS:

- 1. Status of Grant Applications -
 - The Legacy funds have been depleted. Jerry will help Scotty write the final report to be submitted to the Legacy Foundation. Scotty applied for another \$5,000 Legacy grant.

- We are still waiting to hear as to whether or not we were selected to receive funds from the Friends of the Poor grant.
- 2. Ozanam Training starts at 8:30 a.m September 25th, at St. Patrick in Bisbee Marianne is unable to attend. If anyone wants to take her place let Pauline know.
- 3. To reiterate what was written in the minutes, effective immediately we will no longer call St. Andrews for funds to assist our friends. The September check was returned to SVDP and we can use it in our budget. Gini will discuss this with the Finance Committee. If friends go to St Andrews, prior to providing assistance, St Andrews will refer them to us to see what type of assistance we can provide them.
- 4. The one mile "Walk for the Poor" is Saturday September 25th after the 9:00 a.m. Mass. Meet at St. Andrews around 9:45 a.m. and walk to the Food Bank on Bartow.
