Vincentian Reports on difficult or touching cases:

Mary had 2 touching cases:

- 1. Scott Mase and family, with 2 children, 11 and 15, that already had DES paying their back rent and the apartment complex still had the police evict them. Shelters were full so Mary called St. Andrew's who paid for 2 nights. If GNA cannot get them into Rapid Housing Program immediately, they will call GNA daily. They can return for up to a week for a hotel if GNA cannot take them.
- 2. Gustava Cruz and Denise Rosa brought their family including a 3 month old and a 5 year old. Their phones are already turned off. Mary told him about T-Mobile free phone. They were behind in back rent and fees, of \$647. September rent is \$460. They called after hours and said their parent could pay \$200. St. Andrews will cover \$250 and Utilities for \$100. He delivers packages, minimal hours. Mary told him he needs to find a job that fills in. Denise is also looking for work. Mary will request a Special Case from the emergency funds tomorrow for the outstanding \$287.
- 3. Larry and Pauline have a Friend, with two teen boys, he has spent time in jail, he had been beat up and he was extremely stressed, very animated and highly agitated, over his \$64 phone bill. He stressed over not wanting a hand out. Larry explained that this was a hand up, not a hand out. Larry and Pauline both said that prayers worked! He was doubtful. Larry told him that this was Divine Providence.

HOME VISITS: All and Janet delivered a Food Box.

Food for thought:

- Pauline shared an article that said 3.8 million people will be evicted in the next 2 months.
- Al shared that a report in the National news that 1 in 6 Americans are behind in utilities.
