NEW Business:

1. Pauline gave an explanation of the current funds.

- Rent utility budget: ** Good Shepherd Funds will begin February 1, 2024
- United Way Fund balance as of November 30, 2023:
- Utilities: \$3,430 / 3 months = \$1143 per month
- Rent: \$4,650 / 3 months = \$1550 per month
- Regular budgeted amounts used each month:
- Utilities: (\$4400 \$1143 = \$3257) / 20 days = \$160 per day to utilities
- Rent: (\$6000 \$1550) = \$4450 per month
- Per agreement with Anthony we will increase the United Way usage to:
- Utility: \$150 per household, one check
- Rent: \$300 per household, one check
- Use the UW funds first and then use the budgeted rent and utility funds upon depletion of the UW monthly allocation.
- Community Partners balance as of December 30, 2023 = approximately \$5,040.00
- We need to have this fund completely depleted by 27 December in order to submit all documents to Community Partners for reimbursement.
- Rents exceeding \$300 will apply for community partner funds and must state the funds are needed to avoid eviction which could lead to homelessness. What are some statements we can provide?
- 2. FYI the LDS provided another shipment of non-perishables, and dishwasher detergent, on November 30, 2023. Shared with Salvation Army and Bisbee's SVdP
- 3. Canyon Vista released a gentleman Friend to SVdP Conference, who had severe stomach distress, with hopes we could find him a hotel. Sadly he was on the hotel DNR list and an ambulance was called, and also SVPD. He just wanted to return to his campsite. This is the second of this type of incident. What can be done in the future?
