- 7. Dottie has donated a cross she received from Anita Fernandez. We will hang the cross in the waiting room.
- 8. Many blessing to Jose, who has donated \$200 to SVDP from selling his rosaries at the Fish Fry. Items that are blessed can't be sold.
- 9. Amazing we applied for a grant from Safeway and in addition to the gift cards we received, last Monday, we received a \$20,000 grant. We are blessed.
- 10. Epsilon Sigma Alpha Sorority, Alpha Ki Chapter, made a 2<sup>nd</sup> donation of 50 sets of peanut butter and jelly; the first donation was 37 sets, for a total of 80 sets. It's a fund raiser and for each set of peanut butter and jelly donated, you get you name in a basket for a huge gift basket drawing. The fund raiser is expected to go on for another month.
